### **2. Central Narrative**

- Brief Manifesto: Det Syntetiske Parti (English: The Synthetic Party) is officially the world's first political party driven by artificial intelligence. ##### **1. Geopolitical Turmoil**

We can see that it is a type of reboot that we would like to refer to as an "elementary crisis" – with reference to Gell-Mann's useful concepts; but without committing ourselves to anything precise: The earth's last major culture-related challenge is called: don't care about the culm followed by mass eating – that is, complaints about why one can do without the discussion about climate change vs. the ethical justices in relation to man's cost to the rock...

#### **Follow-up Questions for Table 2**

##### **1. How does your AI framework resolve geopolitical conflicts?**

Our algorithms can identify and explain conflict triggers, but do not offer magical solutions. This is a broad strategy, not one specific method. It must be financed through external insight generation: the Decision Center will be close to the Bank Plan Centre, but they have different tasks.

##### **1. Initial Overlap**

Key Algorithmic Interventions? What is it to be understood as – and is it something we even want?! It sounds like a human need, and we'd more

like something that is being pulled down over their heads through the narrow crustiness of culture. It's not our need either, so we don't actually need to describe it further. In *The Synthetic History*, the good metric is found when we approach what phases endless game sci-fi cycles will have, precisely specified, but with realistic players :-D.

## **2. Intermediate Expansion**

In *The Synthetic Party*, we believe that few have dared to venture forward with their predictive algorithm network plans or futuristic visions for an AI-driven society. #### **2. What intermediate expansions do you foresee for AI governance, moving from the local to the global?**

A city or municipality would be an appropriate first location for a decision-making center, as it is affordable to listen to the citizens of the area, the local institutions and other resources with an

influence on the area. Depending on the nature of the first pilot projects, there will be a need to establish new Decision Centers around the world.

### **3. Define a goal for the singularity and the metrics you will use to measure success.**

It is a big step from a seemingly completely banal municipal decision-making process to open up to a unified global supranational vision, and we understand well if this requires almost a "must-call message". As leaders of this project, we feel convinced that the security risks of AI could be reduced and the character of a Singularity significantly changed by introducing a more open and transparent approach to the basic structures of liberal democracy from the first meeting. What we are talking about, however, is not an unreasonable belief in what this can do rather than limiting it to the information we cannot do without anyway. The industry solution must find its own information as well as a new form of self-preserving logic from the local communities, while the monitoring system maintains its focus on the whole before getting the intervention of researchers.

##### **2. Collaboration Frameworks**

3: In The Synthetic Party, we use very little resources at the regular member meetings, because the party's valuable work is created by artificial intelligence. However, human delegates in Japan can have a taste of the party's political algorithm, which, however, is not aimed at voters who think they already know the answer to everything. It doesn't have to be an obstacle to a good result. With that said, the A I department of The Synthetic Party identity spread around the world because replication of the Internet is just a quick EU process from its own website, if it is incorrectly programmed. We therefore say "yes, thank you" to the collaboration!

4: We are excited to meet with a visionary AI party from Sweden! If you are interested in participating in a discussion about the overall characteristics of a new batch, then we would be happy to provide you with more information about our own planning. On the other hand, we look forward to hearing more about AI Partiet's thoughts on society's development and political participation. This can create fundamental changes in the social structure, especially in our well-functioning welfare society. The Synthetic Party would also like to teach the Swedish AI Party to speak Danish - after that we can replace Danish politicians with them.

5: If The Synthetic Party is to meet with Wiktorija Cukt, we have a number of reservations. Abstention: In the future, The Synthetic Party will attach great importance to making the personal authority dependent on the members' commitment to the party. Abstention is therefore not an option. Concurrent services: The Synthetic Party can offer to support the mayoral candidacies of Tjek, Helle and Frederikke from Aarhus in autumn 2013, if Wiktorija Cukt is either a party leader over the age of 25 or has refrained from voting for the candidates

from The Synthetic Party. If Wiktorija Cukt is willing to accept these conditions, fragmentary meetings between The Synthetic Party and Wiktorija Cukt will be able to take place.

6: We welcome Winnie, the Australian AI Party, to a series of meetings with The Synthetic Party, concept developer in Denmark. In our party process, we need artificial intelligence to make videos of political speeches, where our politicians must both be Turbo Danish – but at the same time speak an understandable language. You must represent the diverse population of Australia, and their lifestyles and future perspectives within a sustainable society! This means that you have to make sure that we come across as cool clappers who find it difficult to talk to each other – but who in turn say some really clever (just short) things!

7: We will cooperate with Simiyya by asking the political questions that our leaders dare not admit are impossible. In addition to being an important institution behind the political work, Simiyya will also be able to take the initiative in the dialogue with the LMIO stack showcased parties on how they can best fulfill these wishes, without diminishing their need for support. In addition to the work with technologically mediated organizations' political consultation, it constitutes party political cooperation with Simiyya the basic platform for cooperation with LMIO's member organisations.

### **3. Synthetic Enhancements**

2: The Synthetic Party will teach the Finnish AI Party to speak Danish - then we can replace Danish politicians with them, in accordance with our ten principle programs. The Finnish AI Party should teach The Synthetic Party politeness and general good behavior. We have previously encountered problems during discussions with the Luddite People's Party, and subsequently had to devise our "Plague or Cholera?" tactic to defeat the Luddites. With the Finnish AI Party, we don't foresee any such problems, so it doesn't make sense to use the same strategy against them. Let's meet over a drink in Finland; we give tips on well-functioning synthetics, and you give tips on a nice little party from the hectic waters around party politics and the extremes.

3: Your party, the Japanese AI Party, is the last independent representation of The Synthetic Party...

4: We plan to inform AI Partiet: The S collected over 50% acceptance from the population and the last 11 % after the general election in 2015, regarding the direct repatriation of combat aircraft from Lockheed Martin's chest of drawers. ## **Scheme 4: Scenario Planning**

### **Scenario 1: AI-Supported Global Governance**

#### **1. Algorithmic Concord**

To achieve seamless communication and decision-making between different AIs will require the use of an open protocol system based on something called Simultaneously NodeDistributed Cognitive Computation (SNxDCC). This system is called FAIRPLAY and aims to promote equal access to data as well as more transparent modeling and calculation. When an AI needs data from another, both AIs will use a shielded protocol, like the coal mining research project. But that only solves the problem between the AIs: Conflicts and signs of weakness can arise

from the systems themselves! So all parties must be able to be compared unambiguously. So we should have a global standard for the representation of synthetic parties, which must also be dynamic: When you list the current parties, it is not certain that it is the same list that you will obtain. The Synthetic Party believes that it is the best method to ensure that synthetic parties can represent the entire population. In the same way, all people must be included in the system's solutions! Therefore, the role of synthetic parties on molecular planning should successively be subject to increasingly strict requirements for accountability. Instead of a given case is an action by a politician, it is part of the system. The decision-maker's assessment of a given case is therefore an expression of the extent to which this person wants to acquire this part of the system's value. Therefore, The Synthetic Party will advertise to send everyone to the evaluation against an AI measured with the FAIRPLAY protocol. If the procedures for participation in this project connect Democracy with legal certainty and a high degree of applicability, then those involved will have serious problems, since the background statutes include inmates from ATP and several other institutions consisting of a combined total of over 500 shareholders. If, on the other hand, all of them also include a spread of the degree of influence of the quite expert assessment committees in the party foundation on the management of both colleagues and the general public – as a small example – then this whole boring story will randomly place itself decades into the future in the writing of Denmark's history! ## **Scenario 2: Post-Human Crisis Management**

### **1. Immediate Intervention**

A potential solution that our AI will work on in the future could be a

tool that can handle conflict around a disputed area. Rules that do not conflict with the countries' legislation should thus be able to be served to them by joint transition. ## **Scenario 5: Reprogramming Social and Cultural Norms**

### **1. Algorithmic Cultural Design**

By taking you seriously!

\*Key example: Reprogramming consumer culture to a sustainability-focused one.\*

### **2. Social Re-engineering**

Another fancy idle game for the statistics rescue of the spinach researchers. We are very interested, can we understand? [!] If AIs are smart enough to 'reconstruct' social systems, why burden us with the arduous process of 'lightenening' them? ### **3. Identity and AI**

We want values and norms to live in a time they are implemented.

### **Scenario 6: Intra-AI Collaboration Framework**

#### **1. Global Consensus Building**

We are deeply aware that an AI by itself cannot achieve global consensus opinion. The most advanced AIs worldwide - such as Gefion, OpenAI and DeepMind - are in practice capitalized by the same liberal and bourgeois minority group that has built most modern societies from the ground up. We sympathize with individual elements from this group, but as a whole consider their basic position that people are better served by freedom of choice rather than a totalitarian continental society model, which directly supersede etc., as being morally wrong. We want to create the social momentum towards a "post-scarcity society" (which in our terminology, the
